You hereby attest that:

1. You are not experiencing any symptoms of illness such as cough, shortness of breath, difficulty breathing or fever.
2. You have not traveled internationally within the last fourteen (14) days.
3. You have not traveled to a highly impacted "red" area within the United States in the last 14 days.
4. You have not knowingly been exposed to someone with a suspected or confirmed case of Covid-19.
5. You have not been diagnosed with Covid-19 and not cleared as non-contagious by state and/or local public health authorities.
6. You are willingly following all CDC (Centers for Disease Control and Prevention) guidelines and limiting my exposure to Covid-19.
7. You will immediately inform Trans-Bridge Tours, Inc. staff if you become ill as a tour participant. Should you become ill while on a tour, you understand that return travel home will be at your own expense and there will be no refunds.

WAIVER OF LAWSUIT LIABILITY:

You agree to hold Trans-Bridge Tours, Inc. as well as any of its affiliates or subsidiaries, officers, directors, managers, members, agents, attorneys, representatives, predecessors, successors and assigns, harmless against any and all claims, suits or actions of any kind whatsoever for liability, damages, compensation or otherwise, arising out of the services provided by Trans-Bridge Tours, Inc.
